Incorporating Assistive Technology into Planning for Students (District 41)

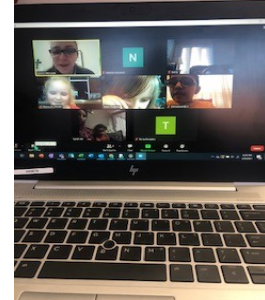

Qualified Interpreters for IEP Meetings

ISBE adopted new rules to support parent participation in IEP meetings by requiring districts to provide for and fund “qualified interpreters” for parents whose native language is other than English. The new requirements are outlined in the Admin Code (23 Ill Admin Code 226.530) At this time, the required assessment and the required trainings have not been developed and ISBE will be developing an RFP. However, documentation that an interpreter was offered, the offer included the option of the interpreter having no other duties and the outcome of that offer is required at each IEP meeting. It is highly recommended that districts begin to train their interpreters or the staff they use as interpreters in areas such as confidentiality, basic special education terms, role boundaries and ethics.
