Brave Spaces

The CASE Equity committee created "Brave Spaces" where all staff have an opportunity to come together to discuss a short equity related video. Tracy Mack (DHH teacher) led the first Brave Spaces conversation and utilized the series, *Uncomfortable Conversations with a Black Man* by Emmanuel Acho to guide the discussion. Glenbard Parent Series-CASE Collaboration

This conference brings together organizations and community members throughout the world that work together to increase their effectiveness through collaboration. Music Therapy

Alyssa will keep all of the current therapists in their current positions and will be hiring as needed. The transition will be very smooth for CASE and our member districts.

We are continuing to work with the directors to encourage district staff to work this summer. We have put out a "enroll by" date of April 16th out to all district staff. Secret Buddy Reveal

As a way to stay connected and meet each other, many members of the CASE staff participated in the CASE Secret Buddy program. Throughout the year, they sent each other tidbits of information, memes, stories, resources – small emails just to let their buddy know they were out there. The culminating event was a reveal Zoom party where participants got to learn who their buddies were.

HB2848 (Amends the Children with Disabilities Article of the School Code)

The House passed HB2748. Students who age out between March 17, 2020 and the last day of the 20-21 school year are entitled to compensatory services (i.e. another year of school). Issues:

- Use of the term "compensatory service" opens this up to all students with IEPs
- No difference between students who did receive services and students who did not It has passed the House and Senator Koehler picked it up in the Senate.
