CASE ESY 2023

This year CASE ESY was a success. We hosted 271 students across two buildings and 33 classrooms. Elsie Johnson there were classrooms K-8 and 8 classrooms at the Early Childhood Center in CCSD 93. CASE ESY continued its partnership with both NEDSRA (Northeast DuPage Special Recreation Association) and the local police departments of Carol Stream, Hanover Park and Bloomingdale.

SUMMER PROFESSIONAL DEVELOPMENT

RBT Cohort:

This summer CASE offered an opportunity for veteran paraprofessionals to receive intensive training on data collection and behavior reduction. This consisted of 40 hours of online trainings and 4 in person meetings with our CASE BCBAs for supplemental training and discussion. Finally, all participants passed a competency assessment and are now studying to sit for the RBT exam.

CASE Summer Workshop Days:

On August 3 & 4, CASE is hosting a 2 day workshop for LBS1s and paraprofessionals working in self contained and special education settings. Marquardt D15 is providing the site for these mock classrooms and the training. More than 35 staff members are registered to attend from District 15, District 16, District 41 and District 89. This workshop will focus on understanding "Structured" (FLEX) and "ESP" (ED/BD) classrooms covering anything from how to set up the environment to individualizing instruction for these unique learners.

NEEDS ASSESSMENT

During the Spring 2023 all member district Directors were presented with the results and data from the '2022-2023 Needs Assessment Surveys.' CASE continues to work with our Directors to support professional development and staffing needs. We have been recognized by many of our districts for our consciencous efforts recruiting talented service providers while keeping in mind the unique needs of our districts.
