Crisis Prevention Institute (CPI) Training



In August, 2022, the CPI training team led by CASE Assistant Director, Maya Raab completed trainings in **Districts 15, 16, 44, and 89** certifying 386 administrators, certified staff, and non-certified staff in non-violent crisis intervention and de-escalation techniques. Five additional trainings will occur in September.

Evaluation Cycles Modified to Three-Year Schedule

Effective this evaluation cycle (2022-2023), CASE staff members rated as “excellent” or “proficient” will follow a three-year evaluation cycle. Public Act 102-0252 amended the Illinois School Code to allow the new cycle. CASE divided all tenured and tenure-equivalent staff into three evaluation groups: Group A, Group B, and Group C. The goal of a quality evaluation process is continuous conversation and reflection. By spreading out the evaluation process, CASE hopes to provide staff members an increased opportunity to connect with administrators, receive feedback, and create more foundational understandings of their work with evaluators.
