## **CASE Learning about Selective Mutism**

After many inquiries from CASE and district special education staff over the past two years, speech-language pathologists Nikki Norman and Tricia Sharkey answered the call for information on Selective Mutism. On November 28, Tricia and Nikki presented to CASE and district staff on Selective Mutism. The prevalence of students in our buildings with a diagnosis of Selective Mutism is currently 1 in 140. This is an anxiety-based disorder that significantly impacts academic and social success. Diagnosis and treatment for students with Selective Mutism is transdisciplinary and requires teamwork and collaboration.
