IDEA Time Out, Isolated Time Out and Restraint

ISBE filed a second amended emergency regulation which permits the use of isolated time out in specific circumstances. The form has been revised and the use of the new form went into effect immediately. Changes include:

- Use of isolated time out is permitted if adults are within two feet of enclosure and only when student is actively engaging in extreme physical aggression
- Notification to parent must be done within one business day (former language was 24 hours)
- Notification to ISBE must be done within two school days (former language was 48 hours)

Training of personnel is currently proposed to be 8 hours of annual training and except for training of physical restraint, training can be done online.

Lauren Witt - IAER Presentation

The Illinois Association for the Education and Rehabilitation of the Blind and Visually Impaired conference was held in late February. Lauren presented in a session that targeted student teachers in the areas of Vision and Orientation & Mobility. Her presentation was entitled "What I Wish I Knew My First Year.

Dupage West Cook Board Meeting

Projections for next year: Deaf/Hard of Hearing (Elementary) – increase of 6 students; Deaf/Hard of Hearing (High School) decrease of 3 students; Vision- decrease of 1 student. They are anticipating a slight increase in the need for related services but no additional teachers. Discussion at Board meeting about out-of-district surcharges and a subcommittee has been formed to study this. Rates for all programs are expected to increase by 2.5% next year for elementary and 1.04% for high school programs.

CASE Institute Day – Additional Highlights

Physical Therapy - The physical therapists met at CASE and discussed the following topics:

including:

- in-depth review, analysis, and discussion of ISBE's 2019 Guidelines for OT and PT and how this directly impacts our daily practice both as PTs and as members of related service teams in the various districts;
- new methods of data collection to track goal progress using various types of technology (google forms being the top choice for ease of use and information collected);
- watched a presentation from a colleague on ways to initiate walking in children who might not be showing the classic readiness signs; and
- discussed the key points from APTA's School Based Practice Course.

Vision Teachers – Vision Itinerant teachers met at the CIS office.

- Looked at role in general education buildings
- Developed language around role and around the Expanded Core Curriculum
- Refined checklists for instruction both for consistency and to have updated resources for unique students
- Created a Vision Itinerant Notebook in One Note so that all can access resources and add information

Hearing Teachers - Hearing itinerant teachers met at the CIS office and worked on:

- SMART IEP goals and PLAAFPs (Present Levels of Academic And Functional Performance)
- Reviewed IEP resources such as the IEP Quality Project, Skill Assessment Tools, the app Common Core by Mastery Connect, and Embrace IEP's goal builder
- Evaluated IEP goals using the SMART guidelines and rewrote them to fit the standard.

December 1 Childcount Directions

The December 1 count has been shut down. All districts are accounted for at this time. The window will re-open for superintendents to verify their counts from March 12-26th.





GPAT is hiring!

February saw one of our original Home Visitors move out of state. We needed to transfer the families with whom she worked (across 4 districts) to other Home Visitors, as our top priority is taking care of the families we already have before taking in any new families. We were able to successfully transfer all 16 families among 4 of our other Home Visitors. All families decided to continue with the program, despite the disruption, which is amazing given other programs' experience with this type of situation. We credit this to contracting with a reliable interpreter working with many of the families, providing continuity, as well as our rotating leadership in ongoing groups. This allows many Home Visitors to know each family who attends, and the family to feel part of a whole—not only connected to one Home Visitor.

We are currently in the interview process to hire a .6 FTE Home Visitor. We plan to have that person concentrate on increasing family participation in Districts 15 and 16, however we always give priority to families with the highest eligibility scores (indicating many stressors) regardless of district.

We have room for 20 more families.

Our referral sources continue to be primarily the

DuPage County Health Department as our source of most referrals, followed by school district personnel, and then families referring other families. This month, we also received a referral from Northwestern Medical Group, two other referrals from other DuPage home visiting programs who knew that the family in question could be best served by us rather than them (due to availability of a Home Visitor speaking Urdu and a contracted interpreter speaking Arabic), and also from a transitional housing/domestic violence site.


Toy and Book Lending Library

Thanks to generous start up funding from ISBE in FY18, we have an abundance of toys and books and parenting resources available for parents to borrow. It may be as simple as sharing blocks or a cause and

effect toy for a few weeks with a family that doesn't have them due to a sudden disruption in their living situation. ISBE allows for us to permanently loan these items when needed.

Groups

We had groups in two locations (Glendale Hts and Glen Ellyn) this month. A renewed connection with the University of Illinois Extension Program Family Nutrition Program has led to a Family Nutrition Educator meeting with parents to talk about how to eat healthy on a budget. We also were able to support parents who wanted to attend the Glenbard EC Collab Jim Gill Family Night held in Lombard, by providing transportation to and from the event for any GPAT family needing this service to participate.



Family Successes

This month, two families passed their citizenship exams. One family purchased their first home. Another two families, both extremely isolated and not knowing many people speaking their first language met at a group and befriended one another. Two families have started ELL classes, and many families have had their children screened for preschool eligibility. We work with them to find a preschool placement if possible, even if they are not eligible for their local school district PreK. Two families had children referred to Early Intervention for evaluation of delays. Two families were provided with resources for marital and/or family counseling. Two parents found different, higher paying jobs to support their family. We are happy for every success, big or small, that GPAT families achieve.

Partner Plan Act CS3 Coaching

Our CS3 Team met with our coach to take a deeper dive into the data we have collected thus far in our community scan. We evaluated results from over 100 local parents, and 20 providers to get a better understanding of developmental screenings usage and knowledge across our community. Initial results indicate that there are many providers and options, however messaging and therefore knowledge of this is not consistent.

We are taking this data and information back to our Core Team and Full Collaboration to determine next steps and strategy design. More to come....

EC Professional Development with Jim Gill

On Saturday (yes SATURDAY) we had 36 dedicated EC professionals come together for a morning of learning with musician and author Jim Gill. Attendees included home visitors, preschool teachers, childcare providers, librarians, EI providers, PT, SLP and even CIS Itinerant staff- truly representing a wide spectrum of EC providers.

Mr. Gill's morning long presentation "Music Play is Learning Play" had professionals thinking critically about the music we use, and most importantly, how we use it intentionally to promote readiness, literacy development, math development and inclusion.

Earlier in the week, the ROE hosted an EC meeting focusing on preschool expulsion and the increased challenges educators experience that are self-regulation/behavior related. Mr. Gill's presentation took a development centered approach that spoke to these specific classroom needs in a developmentally appropriate, culturally appropriate and inclusive way. In addition to this great learning...

- 10 more providers completed our CS3 provider survey.
- 3 expressed interest or knew someone interested in our position
- 1 EI PT offered her services to speak to our families at groups about tummy time and W sitting (AND kindly answered questions a few of us happened to have regarding these topics)
- We made connections and now have contact info on more local preschool providers including some private and 1 park district

The Glenside Library was so incredibly generous and kind in allowing us the space for the morning event. This was a great event for all involved!
