#### **IAASE Fall Conference**

This process is intended to provide leveled supports to districts depending on the areas of need. ## Parents as Teachers Blue Ribbon!

It has been a busy, productive, and rewarding month in the CASE GPAT program. Jeanine Woltman and I presented at 3 different conferences about various aspects of our thriving program at the ISBE Statewide Sharing A Vision conference, the Parents as Teachers International Conference, and the Prevent Child Abuse-Illinois conference. We were happy to be able to share the hard work and specific knowledge of our program, with workshops titled, While at the PAT conference, we were formally announced as receiving the Blue Ribbon award, with all Essential Requirements and 97/100 Quality Standards.



The only way we could have achieved this marker in our first year of CASE GPAT, is due to the strong foundation of the first step of the Blue Ribbon process while still in D41, followed by the extreme effort and ability to connect with families as we ramped up during year 1 of our GPAT grant. Our Home Visitors are extremely talented and hard-working, and I am grateful for them.



# **Family Stories**

This month, we've seen how working closely with district programs benefits families. For example, one family met our Home Visitors at a preschool Open House we were invited to attend. They joined the program, benefit from ongoing home visits, (photo kid reading) and additionally benefit from the connections to needed resources that our Home Visitors bring. This particular family used the services of Sharing Connections, a non-profit organization providing furniture and now the kids have a room that feels warm and inviting and their own beds!





Often, we will get a referral when a child is almost 3 years old. Many home visiting programs do not accept a B-3 referral this late, but we do. Why? Even a small amount of time with a family reaps rewards for the family *and the school district*. For example, one of our Home Visitors saw a family for only about 4 months before transitioning them to a district preschool. When the preschool teacher has questions because the family wasn't responding to the teacher notes back and forth in the backpack, who could she call? The Home Visitor. When the same family had questions about the Holiday gift form she received from the school, who could they ask? The Home Visitor. We seek to be that bridge between home and school and these tiny moments of connection and care for whatever the family's concerns are, large or small, really make a difference over time. As families come to know, early on, that the school district cares about their whole family, they're more likely to attend events and fully engage (I know this from anecdotal evidence, observed over time—we will need to figure out how to measure these outcomes!).

## Connection with Districts and relevant data

In addition to screenings, outreach events, meeting with district staff, this month marked the first time we were able to share with each Superintendent and other key staff the families in each district with whom we work. We hope that this will enable your staff to contact us if needed about a specific family.

In October, <u>we currently have 97 families</u> enrolled in Glenbard Parents as Teachers, 112 children aged birth to 3, and we are serving 6 pregnant women. Our target this year is 110 families, 144 children. By district, here's how it breaks down this month:
