Conference Take Aways:

<u>A Million Paper Cuts: Why Special Education Teachers Leave</u> <u>the Profession.-</u>"Research shows that 50% of special education teachers leave the field within their first five years." This session discussed key findings from research in IL as well as shared ideas to help districts combat this state wide dilemma.

<u>Resilience Education to Advance Community Healing</u> (REACH): A Whole School and Safety and Wellness Program-The REACH program is aligned with ISBE's mental health efforts. This program is working in conjunction with regional ROEs to provide a person to assist with the implementation at no cost to the district.

<u>ABLE – Now Part of the IEP!</u>-This session focused on information about the "Achieving a Better Life Experience" IL ABLE program. The IL ABLE Account is a low-cost, tax-free way for eligible people with disabilities and their families to save and invest money to pay for expenses related to living with a disability. Starting this school year, IL public school special educators are required by law to provide information on ABLE to parents/guardians. Special educators are not required to be experts with IL ABLE, rather provide the general information and resources to parents/guardians.
